- External to Institution



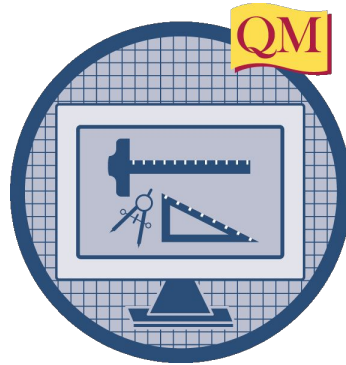

Applying the QM Rubric (APPQMR)

Participants learn about the QM HE Rubric and the process of using it to review an online course. This workshop is a prerequisite for the Peer Reviewer Course.



Peer Reviewer Course (PRC)

Participants are prepared to become a QM-Certified Peer Reviewer with this intensive course focused on the QM quality assurance for course review process.
